It has been a strong start to 2014 with several new activities including the development of core concepts within the Open Software Defined Data Center



(OSDDC) Incubator and the expansion of management standards for software entitlement, network services, and cloud infrastructures. OSDDC related standards should enable programmatic, orchestrated, and automated management of data centers.

More than 25 DMTF standards and four schema releases were made publicly available in 2013. With more than 15 alliances with other standards organizations including ETSI-NFV, CESI, ODCA, SNIA, and UEFI, we continue to expand our reach into many areas while developing industry relevant distributed system management standards in a timely manner.

The organization continues to witness strong engagement from Open Source communities with the implementation of numerous DMTF standards. The DMTF is uniquely positioned to continue developing and publishing de facto management standards covering all management aspects including: low level


