## Cloud Auditing Data Federation Standard Now Available

DMTF recently announced the release of its latest standard – the Cloud Auditing Data Federation (CADF) Data Format and Interface Definitions 1.0. More than a format, the CADF standard defines a full event model anyone can use to fill in the essential data needed to certify, self-manage and self-audit application security in cloud environments.

The CADF Working Group's co-chair Matt Rutkowski concurrently held a live webinar with the announcement of the release, which can now be viewed on-demand on the DMTF website.

## DMTF Debuts NEW Initiative to Address Network Environments

On July 8, DMTF announced its latest initiative for network management – the Network Management Initiative (NETMAN). This effort, designed to unify network management, aims to provide the necessary standards-based management models and interfaces to enable consistent, unified and automated provisioning, deployment, configuration, and monitoring of network environments.

Today's existing and emerging network management standards do not attempt to integrate with server, virtualization and cloud management standards to simplify and unify the management of the overall infrastructure. Building upon the DMTF's widely-deployed management standards, NETMAN is in the unique position to:

- Facilitate interoperable management across multiple network environments
- Enable a common management infrastructure for network resources and services that can span across multiple implementations, including open source solutions
- Deliver effective management of the network environment within new paradigms such as the software defined data center and the Network Function Virtualization initiative

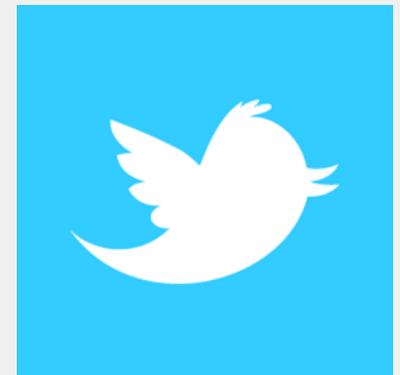

All current WIP documents are listed on the DMTF [website](#) or can be found on specific [Working Group pages](#), where you can also follow each group's upcoming deliverables and other public information. WIP documents are available for review and are displayed indefinitely until the current version is superseded by a newer version, or the document has been approved as DMTF Standard or DMTF Informational.

DMTF members who wish to provide feedback should join the Working Group that produced the document and participate in the editing body at that level. Alliance Partners, the general public, or a company or individual who is not a member of the DMTF may comment on the WIP through the DMTF [Feedback Portal](#), which is accessible after agreement to the DMTF Feedback Policy. This agreement ensures that the DMTF has the copyright to the material, and that the feedback adheres to the DMTF Patent Policy.
