From the Desk of the VP of Regional Chapters

DMTF's China Chapter, established at the beginning of 2013, has been making progress on both technical work and regional marketing efforts with contributions from the DMTF Executive Committee, Regional Chapter Committee (RCC) and China Chapter Board members.



On the Technical Committee side, localization of DMTF standards work has continued to make progress during the first half of 2014. With the emerging trend in China of the public, private and hybrid cloud adoption, the chapter considered several options but decided to focus the first batch of document translations on CIM, the foundation of DMTF standards, and CIMI. Thank you to the China Chapter Technical Committee Chair Tian Zhong and all the China Chapter Board members for their contributions.

On the Marketing Committee side, a series of technical-focused marketing activities have been discussed and included in the China Chapter 2014 work plan, one of which was hosting the International Standard Forum at the China Cloud Computing Conference (CCCC) in Beijing on May 20. Rutkowski, [DMTF Cloud Auditing Data Federation \(CADF\)](#) co-chair and IBM Senior Engineer, presented, "An Overview of Cloud Auditing Support for OpenStack" at the OpenStack Summit in Atlanta. The presentation provided an overview of the recent enhancements made in OpenStack projects to support API and security auditing using the DMTF CADF standard and included fellow speakers from IBM and OpenStack.

Across the globe on May 20, DMTF President Jeff Hilland chaired the International Cloud Computing Standardization Forum hosted by the DMTF China Chapter at the [China Cloud Computing Conference \(CCCC\)](#) in Beijing. The event aimed to introduce global cloud computing standardization achievements to the Chinese IT industry and its customers. Experts from global cloud computing standard development organizations shared their latest progress on cloud computing standardization, examined ways for cloud computing standards to connect with the industry and forecasted developing trends.

Lastly, you can view DMTF Chair of the Board Winston Bumpus' participation in the panel session, "[Lessons Learned in Mobility](#)" from the recent NIST: The Intersection of Cloud and

computing standardization achievements and future trends to the Chinese IT industry and its customers. As the first China-based International Standard Forum, we believe this has provided a good starting point to stimulate cloud standard participation in China. The Forum, the first of its kind, was designed to bring all of the different standard organizations together to discuss cloud standards. DMTF President Jeff Hilland was the forum chair and spoke about DMTF's work. CCCC is the biggest cloud conference in China attracting 30,000 attendees each year for the past six years.

Looking forward to the second half of 2014, the China Chapter will continue to provide native-language DMTF standards and other information to China's vendor community for adoption and inclusion in a variety of products and services. In addition, the chapter will work to create and drive broad industry adoption of the DMTF established standards and specifications throughout the region.

While making progress on the first regional chapter, the RCC will continue to explore additional opportunities for other initiatives in different regions. None of these accomplishments would be possible without the contributions of our members. I would like to take this opportunity to thank the China Chapter, Executive Committee and RCC for their excellent work. We look forward to even greater success in the future!

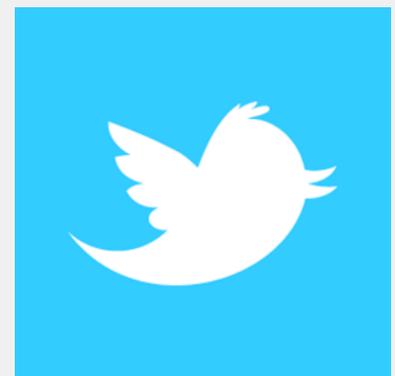
