DMTF recently published the latest release of the Common Information Model (CIM) Schema, <u>version 2.53</u>. The fifty-third update to the <u>Common Information Model (CIM)</u> since the launch of 2.0, this widely used standard provides a common definition of management information for systems, networks, applications and services.

The organization continues to regularly update the CIM schema, helping ensure the standard remains up-to-date to address the latest industry needs.
