## DMTF Standards – ANSI and ISO adoption

[This is the last in a three-part series that provided an overview of the DMTF strategy for securing ANSI and ISO adoption of DMTF standards and the roles played by the InterNational Committee for IT Standards ([INCITS](#)) and DMTF technical working groups and standards sub-committee.]

Parts [one](#) and [two](#) of this series explained what 'de jure' standards are and why DMTF partners with the [ANSI](#)-accredited standards development organization INCITS (InterNational Committee for IT Standards) to achieve ANSI and [ISO/IEC](#) adoption of DMTF specifications.

This third installment discusses the roles and responsibilities of the DMTF Standards Subcommittee and Working Groups in the ANSI and ISO/IEC adoption processes.

When a Working Group decides to seek ANSI and ISO/IEC adoption of a specification, the Standards Subcommittee and the Working Group collaborate to submit the specification to INCITS. The submission involves a two-part process.

The first part of the process is to propose to INCITS that it accept the specification to the INCITS Fast Track program. By accepting the specification into the program, INCITS is confirming that the specification has good reason to become an ANSI standard. The proposal can be made at any time during DMTF's development of the specification. It does not need to wait until the development has been completed, approved or released.

The proposal consists of two documents: a Proposal for Fast Track Processing (Proposal) and a Memorandum of Understanding (MoU) between DMTF and INCITS.

The Working Group writes the Proposal using a template supplied by the Standards Subcommittee. Usually several pages in length, the proposal explains the specification's function, the business rationale for why it should be a standard and the relationship between the specification and other standards.

The Standards Subcommittee authors the MoU and coordinates the actual submission of the Proposal and MoU to INCITS. The MoU specifies lifecycle responsibilities and licensing terms. It is a pre-negotiated document that is mostly a boilerplate, requiring few, if any, changes.

Approval of the Proposal and MoU usually takes 30 days or less. In most instances approvals are received while the specification is still in development.

The second part of the process is the review and approval of the actual specification. While the Proposal can be submitted to INCITS at any time, specifications can only be submitted after they have been released by DMTF. Specifications which successfully complete the 'Fast Track' review and approval

process are officially recognized as an ANSI standard.

## DMTF Standards – ANSI and ISO adoption cont'd

The 'Fast Track' proposal, review and approval process takes an average of six to nine months to complete. Subsequent publication by ANSI can take an additional three to six months, making the entire process take approximately one year. The variance in approval time is due to delays caused by administrative workloads and the need to resolve questions that arise during public reviews of the specification. The INCITS and ANSI staff process hundreds of standards each year.

## New "Sharing Groups" Help Members Follow DMTF Activities

The DMTF working groups, committees and subcommittees are constantly working on new projects and initiatives. This flurry of activity can often make it challenging for members to keep track of what each group is doing. Additionally, much of the information pertaining to individual groups cannot be accessed by those who are not group members. To solve this problem, DMTF has developed two new groups specifically designed for members who want more access to groups in which they are not directly participating.

The two new DMTF information sharing groups are the Leadership Sharing Group and the Sharing Group. The Leadership Sharing Group is open to all Board and Leadership level members. These companies will be allowed to access consolidated views of all documents, calendars, ballots and email for all working groups, subcommittees and committees. The Sharing Group is open to all participating level members. They will have access to consolidated views of documents, calendars, ballots, and email for working groups. Forum information will still be restricted to Forum members.

This project doesn't provide access to any information a user wouldn't normally be able to see had they joined a particular group roster. Rather, this allows project participants to join a single group to gain access to all other groups they could have joined, without being added to the email lists.

These sharing groups are a great opportunity for members to stay informed about the on-goings of DMTF. This is a functional solution for members to stay up-to-date on all DMTF activities while keeping up with their busy schedules.
