Message from the Chairman: Our Alliances Further Innovation

This month, I'd like to highlight the growing set of <u>strategic</u> <u>alliances</u> that DMTF has developed with related technology groups to significantly enhance our collective impact on the industry. We encourage DMTF members to think of ways to optimize these existing relationships, as well as seek new opportunities for additional engagements.

Many of you may be aware of our alliance with <u>SNIA</u> (Storage Networking Industry Association) and the creation of the SMI–S (Storage Management Initiative Specification). DMTF models and profiles form the foundation of that initiative, which is a testament to how these two groups continue to collaborate to revolutionize storage management. a set of standard services for managing energy in the data center.

By working across the spectrum of our alliances, DMTF gains the ability to help build a comprehensive set of management solutions across the breadth of resource domains, with additional depth provided by experts in the fields of telecom (TM Forum), grid/virtualization (Open Grid Forum), blades (Blade Systems Alliance), printers (Printer Working Group), and many others.

As part of these alliances, we are also facing new challenges in working with existing models. A good example is the initiative with <u>TM Forum</u> around <u>CIM-SID</u> synergy-where we need more of a federated model. Our recent <u>CMDB federation</u> specification is another example. Sharing intellectual property between organizations and collaborating with the subject domain experts to capitalize upon our respective expertise in the core models are a few of these new challenges that we're working through.

We are also pursuing another level of alliance partnerships to facilitate work with various vertical industries, such as retail, health, finance and manufacturing. With these industries, vendors are realizing the value of aligning their specific models with those of the global IT industry. This helps these vertical industries that are reliant on good IT practices to deliver better products and service to their customers, and opens up a new level of alliances for DMTF. For example, several standards organizations from the retail vertical industry have already started discussions with DMTF on how they might best leverage CIM.

DMTF is rapidly evolving, bringing more opportunities to shape the industry. We invite you, our members, to both bring forward ideas for future developments, as well as help us execute on our alliance work registers (which our VP of Alliances, Mark Carlson, manages and maintains). I encourage you to check out the current set of <u>alliance partners</u> and read the work registers, think of ways to optimize these relationships, as well as seek opportunities for additional engagements. We can all be stronger by working together, both within DMTF and within the industry.

Seven Preliminary Specs for Member Review

USB Redirection Profile

A preliminary release 1.0.0a of the USB Redirection Profile (<u>DSP1077</u>) has been announced. DSP1077, prepared by the DMTF <u>Server Management Working Group</u> (SMWG), extends the management capabilities of referencing profiles and provides the capability to manage USB redirections provided by the system. For keyboard, video, and mouse (KVM) devices, this profile should be used if the devices are to be managed as USB devices. Otherwise, the KVM Redirection Profile (<u>DSP1076</u>) should be used.

USB Redirection Profile to CLP Mapping Specification

DMTF has issued a 1.0.0a release of the USB Redirection Profile to CLP Mapping Specification (DSP0837), also owned by the SMWG. DSP0837 defines the <u>SM CLP</u> (Server Management Command Line Protocol) mapping for <u>CIM</u> (Common Information Model) elements described in the <u>USB Redirection Profile</u>. The information in this specification, combined with SM CLP-to-CIM Common Mapping Specification V1.0, is intended to be sufficient to implement SM CLP commands relevant to the classes, properties and methods described in the USB Redirection Profile using CIM operations.

Media Redirection Profile to CLP Mapping Specification

This month, DMTF issued a preliminary release 1.0.0a of the Media Redirection Profile to CLP Mapping Specification (<u>DSP0843</u>). Prepared by the SMWG, DSP0843 contains the requirements for an implementation of the SM CLP to provide access to -- and implement the behaviors of -- the Media Redirection Profile (<u>DSP1086</u>).

Media Redirection Profile

Version 1.0.0a of the Media Redirection Profile (<u>DSP1086</u>) has also been released by DMTF. Prepared by the SMWG, this profile extends the management capabilities of referencing profiles and provides the capability to manage Media redirections provided by the system. The target audience for this specification is implementers who are writing CIM-based providers or consumers of management interfaces that represent the components described in this profile.

Standard metric registries: Various working groups within DMTF are defining standard metrics for their management domains. Often these metrics have overlapping semantics with the key difference between them being the context in which they are used. In order to avoid duplication and reduce the number of standard metrics defined by DMTF, there is a need to coordinate the definition of the metrics and consolidate them in a single canonical source. The single canonical source for standard metrics defined by DMTF will be one or more metric registries. This allows multiple specifications (such as two profiles) to reference the same standard metric definition embodied in the metric registry, rather than potentially duplicate definitions in line.

The standard metric registries will be XML documents published by DMTF. Preliminary releases of the standard metric registries are:

- **Standards Metrics Schema** (<u>DSP8020</u>) defines an XML schema governing the format and content of a standard metric registry.
- Metrics Class Template Generation XSL (<u>DSP8025</u>) automates the process of exporting a MOF representation of an instance of the CIM_BaseMetricDefinition class that corresponds to a standard metric.
- **Statistics Class Generation XSL** (<u>DSP8024</u>) automates the process of exporting the MOF representation of a sub-class of CIM_StatisticalData that corresponds to one or more standard metrics.

DMTF and The Green Grid plan to collaborate to develop an interface for heterogeneous management, across data centers, and for IT and non-IT equipment.

The Green Grid is a global consortium chartered to develop energy efficiency standards, processes, measurements and technologies for global data centers and business computing ecosystems. As DMTF is an industry organization leading the development, adoption and promotion of interoperable management initiatives and standards, DMTF will support The Green Grid in reaching its mission.

2007 Member Survey Results: Interoperability

In this series, DMTF continues to report on findings from its annual member survey conducted in January 2007. About 135 members responded at length to our survey. We asked the members to select the most important interoperability priority for their company.
