## **Open Compute Project**

The Open Compute Project (OCP) is a collaborative community focused on redesigning hardware technology to efficiently support the growing demands on compute infrastructure.

The purpose of OCP is the development, distribution and promotion of data center storage, data center server, and data center facility specifications and related software that may be implemented by anyone and utilized by anyone, provided such implementation and utilization is in compliance with applicable license agreements with OCP.

## **DMTF**

DMTF (formerly known as the Distributed Management Task Force) creates open manageability standards spanning diverse emerging and traditional IT infrastructures including cloud, virtualization, network, servers and storage. Member companies and alliance partners worldwide collaborate on standards to improve the interoperable management of information technologies.

Internationally recognized by ANSI and ISO, DMTF standards enable a more integrated and cost-effective approach to management through interoperable solutions.

Simultaneous development of Open Source and Open Standards is made possible by DMTF, which has the support, tools, and infrastructure for efficient development and collaboration.

## **Alliance Benefits**

This alliance provides the following benefits:

- OCP may reference or prescribe DMTF Redfish technology for managing of platforms
- OCP may reference or prescribe DMTF Platform Management Communications Infrastructure (PMCI) and SPDM (Security Protocol and Data Model) technology for managing of platform components
  
- DMTF members may attend OCP project and workstream meeting to provide manageability expertise
- DMTF and OCP can align their standards

- DMTF can submit feedback and contributions OCP by attending the relevant OCP meeting.
- OCP and DMTF can host meetings to exchange and discuss public information

Except as described above regarding feedback and contributions to each other’s specifications, unless otherwise agreed to in writing, no sharing of information, documentation, or materials shall result in the assignment, transfer, or license of intellectual property from one party to the other.

- Redfish Specifications, whitepapers, presentations, schema and mockups
- PMCI Specifications, whitepapers, and presentations
- SPDM Specification, whitepapers, and presentations

- Public whitepapers, presentations and other educational material.
