

The UALink / DMTF Work Register

The DMTF Work Register is created between DMTF and the Ultra Accelerator Link Consortium, Inc. (“UALink”) to formally define the objectives, scope, benefits, and deliverables of the alliance partnership. The register helps both organizations coordinate efforts to achieve the stated goals and objectives.

UALink

UALink – Ultra Accelerator Link Consortium, Inc. - is an industry consortium delivering developing interconnect technical specifications that facilitate direct load, store, and atomic operations between AI Accelerators. UALink specifically focuses on enabling low latency/high bandwidth fabric, supporting hundreds of accelerators in a pod, and facilitating simple load and store semantics with software coherency.

DMTF

DMTF is an industry standards organization working to simplify the manageability of network accessible technologies through open and collaborative efforts by leading technology companies. DMTF creates and drives the international adoption of interoperable management standards, supporting implementations that enable the management of diverse traditional and emerging technologies including cloud, virtualization, network, and infrastructure.

Alliance Goals

The goals of the alliance are:

- Enable a holistic management experience
- Promote UALink and DMTF standards to member companies
- Fosters UALink participation at the DMTF Alliance Partner Technical Summit and in various working groups

Limitations

UALink will use reasonable efforts to not produce delegated standards that materially conflict or diverge from existing or proposed DMTF standards where possible.

DMTF will use reasonable efforts to not produce delegated standards that materially conflict or diverge from existing or proposed UALink standards, where possible.

Access

DMTF and UALink may want to provide documentation and collateral to each other. This information can be exchanged publicly, or not.

For information which can be accessed publicly:

- DMTF will provide access to information and specifications available by releasing and posting documents on the public DMTF website. The documents will be released as either “Work-in-Progress”, “Informational”, or “Standard”.

- UALink only publishes “Released” documents.

DMTF and UALink may come together in an ad-hoc group or committee in order to address any of the matters under this Work Register (the “**Ad-Hoc Group**”).

It is the intent of the parties that they will use the Ad-Hoc Group meetings as the mechanism for each party’s sharing of its confidential information to the other party, including without limitation a disclosing party’s still-confidential specification documents or any other information of a disclosing party that involves its intellectual property (that is information to be contributed to each other’s projects).

For clarity, the parties agree that UALink is not required to use the DMTF Technology Submission Portal (dmtof.org/standards/feedback) when UALink decides to share its still confidential specification documents or other confidential information with DMTF hereunder, but, instead, can share such information with DMTF through the Ad-Hoc Group meetings.

Copyrights and Other Intellectual Property Rights

(a) Copyright-Protected Works.

If one party (“Submitting Party”) submits a contribution, including without limitation any copyrightable content (“Submitted Work”) to the other party (the “Receiving Party”) under this Work Register, then the following governs the use of such Submitted Work: (i) the Submitting Party hereby grants to the Receiving Party a perpetual, worldwide, non-exclusive license to include and use the Submitted Work in any of the Receiving Party’s specifications or other documentation; and (ii) the Receiving Party, however, must give the Submitting Party proper copyright attribution, as contemplated under U.S. copyright law, for such Submitted Work.

(b) No Other Intellectual Property Rights Granted.

Except as set forth in subsection (a) above or as otherwise described above regarding feedback and contributions to each other’s specifications, and unless otherwise agreed to in writing, no sharing of information, documentation, or materials between the parties shall result in the assignment, transfer, or license of intellectual property from one party to the other party.

UALink will make the following documents available to DMTF.

- Publicly available or “released” versions of the following: whitepapers, presentations, specifications, and other educational material.
